Re: New Policy on Visitor Parking plus Other Reminders

<u>VISITOR PARKING – Change in Policy Effective December 17, 2014</u>

- 1. Changed From: permit required if parked over 4 hours
- 2. **CHANGED TO:** permit required from 12 midnight to 6:00am

REMINDERS:

- 1. <u>Assigned Parking</u> Went in to effect Oct 30, 2014 and everyone should be using their assigned parking space and not someone else's. Other things to remember:
 - a. VENDORS WILL NOT BE TOWED
 - b. NO TOWING ON NATIONAL HOLIDAYS as well as New Year's Eve, Christmas Eve and Day after Thanksgiving.
- 2. <u>Dryer Filters</u> please clean dryer filter after each use to prevent fire.
- 3. <u>Temperature Setting for Condo Units</u> During winter or consistent cold weather, thermostats should be set at no lower than 65 degrees.
- 4. Exterminator If you have problems with bugs or rodents: tenants should contact their unit owner, if no satisfaction, contact our property manager, Shaunda Harrison at 302-737-0111 and she'll arrange for exterminator. Exterminator services are paid for by the Association.
- 5. <u>Sprinkler Heads</u> sprinkler heads are located in the apartment-style units. **PLEASE <u>DO NOT</u>** paint or touch sprinkler heads; you must paint around them.
- 6. <u>Trash</u> We pay at least \$500.00 extra per month to remove trash left outside of dumpsters. **All** trash, should be placed inside the dumpsters. <u>Large furniture and appliances are not to be placed in dumpsters or left outside dumpsters</u>; call Shaunda to have hauled away.
